CALIFORNIA EGG PRODUCTION

California's egg production during July totaled 261 million, down 1 million from June's production and down 81 million from July 2022. The all layers during the month totaled 11.0 million, down 4 percent from last month, and down 21 percent from July 2022. Eggs per 100 layers during the month were 2,383, compared to 2,311 a month earlier, and 2,481 in July 2022.

U.S. JULY EGG PRODUCTION

United States egg production totaled 9.37 billion during July 2023, up 3 percent from last year. Production included 8.03 billion table eggs, and 1.34 billion hatching eggs, of which 1.25 billion were broiler-type and 95.7 million were egg-type. The average number of layers during July 2023 totaled 384 million, up 4 percent from last year. July egg production per 100 layers was 2,438 eggs, slightly down from July 2022.

All layers in the United States on August 1, 2023, totaled 385 million, up 3 percent from last year. The 385 million layers consisted of 316 million layers producing table or market type eggs, 65.0 million layers producing broiler-type hatching eggs, and 3.61 million layers producing egg-type hatching eggs. Rate of lay per day on August 1, 2023, averaged 78.8 eggs per 100 layers, down slightly from August 1, 2022.

U.S. EGG-TYPE CHICKS HATCHED

Egg-type chicks hatched during July 2023 totaled 50.4 million, up 1 percent from July 2022. Eggs in incubators totaled 48.8 million on August 1, 2023, down 2 percent from a year ago.

Domestic placements of egg-type pullet chicks for future hatchery supply flocks by leading breeders totaled 196 thousand during July 2023, up 18 percent from July 2022.

U.S. BROILER-TYPE CHICKS HATCHED

Broiler-type chicks hatched during July 2023 totaled 848 million, down 1 percent from July 2022. Eggs in incubators totaled 725 million on August 1, 2023, down slightly from a year ago.

Leading breeders placed 7.85 million broiler-type pullet chicks for future domestic hatchery supply flocks during July 2023, up 4 percent from July 2022.

U.S. TURKEY HATCHERY PRODUCTION

Turkey eggs in incubators on August 1, 2023, in the United States totaled 27.4 million, up 1 percent from August 1, 2022. Eggs in incubators were up 2 percent from the July 1, 2023, total of 27.0 million eggs.

Turkey poults hatched during July 2023, in the United States totaled 22.5 million, up slightly from July 2022. Poults hatched were down 6 percent from the June 2023 total of 24.0 million poults.

The 21.9 million net poults placed during July 2023 in the United States were down slightly from the number placed during the same month a year earlier. Net placements were down 5 percent from the June 2023 total of 23.1 million.
