United States Commercial Slaughter

Commercial red meat production for the United States totaled 4.26 billion pounds in February 2023, down 4 percent from the 4.43 billion pounds produced in February 2022.

Beef production, at 2.09 billion pounds, was 7 percent below the previous year. Cattle slaughter totaled 2.55 million head, down 5 percent from February 2022.

Veal production totaled 3.80 million pounds, 10 percent below February a year ago. Calf slaughter totaled 25,700 head, down 16 percent from February 2022.

Pork production totaled 2.16 billion pounds, down 1 percent from the previous year. Hog slaughter totaled 9.97 million head, up slightly from February 2022.

Lamb and mutton production, at 10.1 million pounds, was up 9 percent from February 2022. Sheep slaughter totaled 154,800 head, 8 percent above last year.

Pacific Region Commercial Slaughter

California's production of red meat during February 2023 totaled 107 million pounds (dressed weight), 23 percent below February 2022. This figure includes slaughter in Federally-inspected and state-inspected plants, but excludes farm slaughter. In February 2023, the average live weight of cattle slaughtered in California was 1,331 pounds, sheep and lambs averaged 151 pounds, and hogs averaged 239 pounds. In Hawaii, 700,000 pounds of red meat were produced in February 2023.
