

# CASH RECEIPTS

Cash receipts from marketings of all farm commodities in Illinois during 2009 totaled 14.5 billion dollars, 4 percent less than during 2008. Receipts from crops totaled 12.7 billion dollars, down 3 percent from 2008, and represented 87.3 percent of the total cash receipts. Livestock receipts totaled 1.85 billion dollars, down 13 percent from 2008, and accounted for 12.7 percent of the total.

Cash receipts for corn totaled 7.53 billion dollars, 52 percent of the total, and were down 11 percent from 2008. Soybean receipts, at 4.23 billion dollars, increased 22 percent from 2008, and accounted for 29 percent of total cash receipts. Wheat cash receipts in 2009 decreased to 221 million dollars, down 41 percent from 2008.

During 2009, cash receipts decreased 3 percent for hogs and decreased 16 percent for cattle. Total receipts for hogs were 952 million dollars, 7 percent of the total cash receipts. Receipts for cattle were 487 million dollars and accounted for 3 percent of the total. Receipts for dairy products decreased 31 percent to 255 million dollars.
