**Maryland** egg production totaled 56.1 million during August 2023, up 7 percent from last year. Production included 54.5 million table eggs, and 1.6 million hatching eggs. The total number of layers during August 2023 averaged 2.09 million, up 5 percent from last year. August egg production per 100 layers was 2,680 eggs, up 2 percent from August 2022.

**New York** egg production totaled 148.0 million during August 2023, down 2 percent from last year. The total number of layers during August 2023 averaged 5.60 million, down 3 percent from last year. August egg production per 100 layers was 2,645 eggs, up 1 percent from August 2022.

**Pennsylvania** egg production totaled 714.3 million during August 2023, up 8 percent from last year. Production included 670.9 million table eggs, and 43.4 million hatching eggs. The total number of layers during August 2023 averaged about 27.7 million, up 10 percent from last year. August egg production per 100 layers was 2,581 eggs, down 2 percent from August 2022.
