



WHEAT STOCKS (Thousand Bushels)




CORN STOCKS (Thousand Bushels)



MONTHLY PRICE RECEIVED FOR SOYBEANS



(Dollars per Bushel)






COTTON growers intend to plant 390,000 acres in 2024, up 3% from last year.

SOYBEAN plantings, expected to total




CORN PLANTINGS (Thousand Acres)




PEANUT growers intend to plant 120,000 acres in 2024, down 3% from 2023.

WINTER WHEAT plantings totaled 410,000 acres, down 15% from last year.




SOYBEAN PLANTINGS (Thousand Acres)





SOWS FARROWING

North Carolina producers intend to farrow 390,000 sows during the March – May 2024 quarter and 395,000 sows during the June – August 2024 quarter.

PIG CROP

The State's pig crop during the December 2023 – February 2024 period totaled 4.29 million head, down 2% from the same period last year.

PIGS PER LITTER

The number of pigs saved per litter averaged 11.15 head, up 4% from the same quarter last year.




