NORTH DAKOTA CROP PROGRESS AND CONDITION

FARGO, N.D. November 30, 2020 - For the week ending November 29, 2020 there were 5.3 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 29% very short, 40% short, 30% adequate, and 1% surplus. Subsoil moisture supplies rated 27% very short, 38% short, 33% adequate, and 2% surplus.

Field Crops Report: Winter wheat condition rated 4% very poor, 5% poor, 50% fair, 39% good, and 2% excellent.

Pasture and Range Report: Pasture and range conditions rated 16% very poor, 32% poor, 39% fair, 12% good, and 1% excellent.

Stock water supplies rated 13% very short, 34% short, 53% adequate, and 0% surplus.

This is the last weekly Crop Progress and Condition report for the 2020 growing season. We would like to extend our appreciation to the dedicated county FSA and extension staff who supplied the necessary information for these reports. For December through March, we will issue monthly reports. The first monthly report (for December) will be issued January 4, 2021. Weekly reports will begin April 5th for the 2021 season.

Data for this news release were provided at the county level by USDA Farm Service Agency, NDSU Extension Service, and other reporters across the State.
