NORTH DAKOTA CROP PROGRESS AND CONDITION

FARGO, N.D. June 14, 2021 - For the week ending June 13, 2021, there were 4.9 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 25% very short, 37% short, 35% adequate, and 3% surplus. Subsoil moisture supplies rated 35% very short, 35% short, 29% adequate, and 1% surplus.

Field Crops Report: Soybean condition rated 10% very poor, 20% poor, 46% fair, 23% good, and 1% excellent. Soybeans emerged was 83%, well ahead of 55% last year, and ahead of 75% for the five-year average.

Spring wheat condition rated 14% very poor, 20% poor, 37% fair, 27% good, and 2% excellent. Spring wheat emerged was 94%, near 90% last year and 95% average. Jointed was 46%, well ahead of 26% last year, and near 43% average. Headed was 2%, near 1% last year and 3% average.

Durum wheat condition rated 4% very poor, 13% poor, 28% fair, 46% good, and 9% excellent. Durum wheat emerged was 78%, behind 92% last year and 91% average. Jointed was 20%, behind 25% last year and 36% average.

Winter wheat condition rated 11% very poor, 27% poor, 42% fair, 20% good, and 0% excellent. Winter wheat jointed was 87%, equal to last year, and near 89% average. Headed was 29%, near 27% last year, but behind 36% average.

Corn condition rated 6% very poor, 13% poor, 39% fair, 40% good, and 2% excellent. Corn emerged was 90%, ahead of 71% last year, and near 86% average.

Canola condition rated 8% very poor, 26% poor, 37% fair, 28% good, and 1% excellent. Canola emerged was 80%, near 76% last year, but behind 89% average.

Sugarbeet condition rated 1% very poor, 5% poor, 31% fair, 48% good, and 15% excellent.

Oats condition rated 7% very poor, 19% poor, 41% fair, 32% good, and 1% excellent. Oats emerged was 95%, ahead of 79% last year and 89% average. Jointed was 48%, ahead of 33% last year, and near 45% average. Headed was 2%, near 6% average.

Barley condition rated 14% very poor, 22% poor, 41% fair, 22% good, and 1% excellent. Barley emerged was 95%, ahead of 83% last year, and near 93% average. Jointed was 46%, well ahead of 22% last year, and near 44% average. Headed was 1%, near 3% average.

Dry edible peas condition rated 4% very poor, 19% poor, 35% fair, 39% good, and 3% excellent. Dry edible peas emerged was 83%, near 87% last year, and behind 91% average. Blooming was 1%, near 3% last year, and behind 8% average.

Sunflowers planted was 84%, ahead of 76% last year, but near 87% average. Emerged was 41%, near 39% last year, but behind 52% average.

Flaxseed condition rated 6% very poor, 24% poor, 32% fair, 36% good, and 2% excellent. Flaxseed emerged was 70%, near 68% last year, but behind 78% average.

Potato condition rated 6% very poor, 12% poor, 65% fair, 17% good, and 0% excellent. Potatoes emerged was 93%, well ahead of 42% last year and 73% average.

Dry edible bean condition rated 11% very poor, 19% poor, 51% fair, 17% good, and 2% excellent. Dry edible beans planted was 98%, ahead of 86% last year and 93% average. Emerged was 75%, well ahead of 52% last year, and near 71% average.

Alfalfa condition rated 20% very poor, 31% poor, 31% fair, 18% good, and 0% excellent. Alfalfa first cutting was 7%, near 11% last year, and behind 16% average.

Pasture and Range Report: Pasture and range conditions rated 28% very poor, 32% poor, 29% fair, 11% good, and 0% excellent.

Stock water supplies rated 34% very short, 31% short, 35% adequate, and 0% surplus.
