NORTH DAKOTA CROP PROGRESS AND CONDITION

FARGO, N.D. November 29, 2021 - For the week ending November 28, 2021, there were 5.1 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 16% very short, 31% short, 50% adequate, and 3% surplus. Subsoil moisture supplies rated 28% very short, 32% short, 38% adequate, and 2% surplus.

Field Crops Report: Winter wheat condition rated 4% very poor, 27% poor, 40% fair, 24% good, and 5% excellent.

Sunflowers harvested was 96%, near 98% last year, but ahead of 84% for the five-year average.

Pasture and Range Report: Pasture and range conditions rated 46% very poor, 27% poor, 20% fair, 7% good, and 0% excellent.

Stock water supplies rated 30% very short, 41% short, 29% adequate, and 0% surplus.

This is the last weekly Crop Progress and Condition report for the 2021 growing season. We would like to extend our appreciation to the dedicated county FSA and extension staff who supplied the necessary information for these reports. For December through March, we will issue monthly reports. The first monthly report (for week ending January 2) will be issued January 3, 2022. Weekly reports will begin April 4th for the 2022 season.

Data for this news release were provided at the county level by USDA Farm Service Agency, NDSU Extension Service, and other reporters across the State.
