2015 Washington Wine Grape Utilized Production Down 2 Percent Average Price per Ton Up 35 Dollars From Previous Year

Washington's 2015 wine grape production totaled 222,000 tons, down 2 percent from 2014. Overall, production of red varieties was up 5 percent from last year compared to an 8 percent decrease in the production of white varieties. Of the top four producing varieties, Cabernet Sauvignon showed the largest increase, up 12 percent from 2014. Growers received an average of \$1,145 per ton for all varieties in 2015, up \$35 from the previous year. Of all the published varieties, Grenache received the highest price per ton at \$1,722. Red varieties in 2015 accounted for 51 percent of the total production, compared to 47 percent in 2014. Cabernet Sauvignon was the top producing variety grown in the State at 47,400 tons or 21 percent of the total. White Riesling was ranked second, at 44,100 tons or 20 percent of the total. Next was Chardonnay with 42,000 tons or 19 percent of the total. Merlot ranked fourth with 35,200 tons or 16 percent of the total. The average Cabernet Sauvignon price increased \$79 per ton from last year to \$1,527 and the average Merlot price per ton increased \$51 per ton from last year to \$1,231. The average Chardonnay price was up \$4 per ton from 2014 to \$926. Growers received an average of \$760 per ton for White Riesling, \$39 less than 2014.

It should be noted that the 2015 production and price for all wine grapes is preliminary and is subject to revision in July 2016.
